Terms of Registration

- **Age Requirement:** To enroll in BNS Summer Fun, child(ren) must be three (3) years-old by the first day of BNS Summer Fun and not older than five (5) years-old. Please note, children must be toilet trained to attend.
- **BNS Summer Fun Hours:** Camp hours are 9:30-1:30pm, Monday-Friday.
- **BNS Summer Fun Pick-Up Time and Late Pick-Up Fee:** BNS Summer Fun ends at 1:30pm. All children must be picked up promptly each day. A fee will be assessed if my child is picked up late. Late pick-up fees are as follows: First 5 minutes - \$5.00; Over 5 minutes - \$2.00 per minute.
- **BNS Enhanced COVID-19 Protocols:** Families should reference the BNS Enhanced COVID-19 Protocols, distributed to BNS Summer Fun families and available on BNS’ website, for a full list of BNS policies and protocols in place in response to COVID-19.
- **Refund Policy:**
 - Withdrawal on or before April 30, 2023: All tuition minus \$100 withdrawal fee.
 - Withdrawal after April 30, 2023: There are no tuition or fee refunds due to absences and there are no make-up classes.
 - If BNS cancels a class due to low enrollment all fees will be refunded.

1. Required Forms: All children MUST have an up-to-date and complete student file in order to attend school. The required forms include:
- Emergency Form
 - Maryland Health Inventory Form
 - Maryland Department of Health and Mental Hygiene Immunization Certificate
 - Blood Lead Testing Certificate
 - Medication Administration Authorization Form (only required for students who require medication or treatment at school)
2. Covid -19 Tuition Addendum. Any closures, either of a classroom or the school, will be determined by BNS after review of orders by the Maryland State Department of Health (MSDH) and Maryland State Department of Education (MSDE) as well as the Montgomery County Department of Health (MCDH). Should the entire Summer Fun program be required to close for a designated quarantine period because of a positive COVID-19 test in the program, or if BNS Summer Fun programming is completely suspended or cancelled due to COVID-19, BNS will refund tuition by 60% for the remainder of the closure.
3. Insurance Waiver. I understand BNS has insurance covering certain injuries, accidents or death occurring during school hours or during school field trips. I hereby waive all claims that are not covered by said insurance against anyone affiliated with BNS, including without limitation the Director, employees of BNS and persons affiliated with BNS.
4. Image Release. I hereby consent to the use of photographs/videos taken of my child(ren) during BNS Summer Fun for publicity or promotional purposes (including publications, presentations, website, social media posts or other media sources) except as detailed on the line below. Individual names of children are never associated with their images. I do this with full knowledge and consent and waive all claims for compensation for use, or for damages.
5. Forfeiture: My signature reflects the understanding that failure to pay tuition or agree to any of the aforementioned provisions will result in your child losing their space in BNS Summer Fun.
